

**MODUS OPERANDI**

Auto Burglary – 7 Incidents – Forced Entry  
 Vandalism – 1 Incident (*Smashed Window*)  
 Primarily occurring in the **afternoon/evening hours (1300-2000 hours)**  
**Public Parking Lots** (i.e. Gym, Park, Boat Ramp, Medical Centers)  
**Primary Target:** Purses

**POSSIBLE SUSPECT VEHICLE**  
**Case #2016-06939 (Rivergate Boat Ramp) – 3/26/16 (SAT)**
